Work.
- Base Bid C - Mechanical  
Work (HVAC).
- Base Bid D - Electrical  
Work.

An alternate bid will be  
accepted for a Single  
Prime General Construc-  
tion Contract to con-  
struct the entire proj-  
ect.

should be made payable  
to the Columbia Borough  
School District.

Bid security in the  
amount of 10% of the bid  
must accompany each  
bid in accordance with  
the Instruction to Bid-  
ders.

The successful bidder  
must furnish to the  
School District a Perform-  
ance Bond and a sepa-  
rate Payment Bond, each  
in the amount of 100% of  
the bid, as required by  
the "Public Works Con-  
tractors' Bond Law of  
1967" and in a form ac-  
ceptable to Owner.

This project is subject to  
the provisions of the  
Pennsylvania Prevailing  
Wage Act, Act No. 442 as  
amended.

No proposal may be  
withdrawn for a period  
of sixty (60) days after  
the date established for  
the receipt of bids.

No cash allowances are  
included in the project.
